1. Step 1: Get in Touch

1.1.3. **Online:** Raise your complaint directly on our website at www.quincecapital.in

1.2. Our promise - we will respond to your complaint within 15 days

2. Step 2: Escalation

2.1. If you aren't satisfied with the solution provided in Step 1, you can escalate the matter to our Grievance Redressal Officer. They will examine your case with due care and diligence and provide a response within 15 days (or explain the reason if more time is needed).
